LODI RULES PEAS 2.0 Reports are due to the Auditor by October 31 of each year but may be submitted early, once pesticide applications are complete for the vintage. The PEAS 2.0 Threshold for the 2023 Certification Year is **225 risk points per acre**. Everything marked by an asterisk (*) is required. The Appl Rate Units (B), Min Rate (A), Rate Adj Points (C), and Base Pts (D) come directly from the Risk Table. If you have several blocks under one application and need tips for simplifying this task, contact the Lodi Winegrape Commission at 209-367-4727.
